CALL TO ORDER:

Mr. Schlegel noted that a quorum of the Board was present, and

Director Johnson called the meeting to order at 6:34 p.m.

APPROVAL OF AGENDA:

Director Schwam moved that the Board approve the agenda as

presented. Upon a second by Director King a vote was taken, and

the motion carried unanimously.

CORRESPONDENCE:

Director Schwam received an email regarding the potential for a

cellular tower in the Perry Park area.

UNFINISHED BUSINESS:

Gateway Pond Water Rights and Water Lease Agreement: Mr. Lis stated that the Substitute Water Supply Plan has not yet been submitted for review pending an agreement to obtain or lease replacement water that may be required and discussed with the Board members possible alternatives for measuring evaporative losses. Mr. Schlegel stated that he and Directors Johnson & Brickweg attended a recent Board meeting of the Perry Park Water & Sanitation District (PPW&SD) to discuss a proposed Water Lease Agreement, that was developed by the PPW&SD, and presented a copy of the proposed lease for the Board's consideration. Mr. Ela discussed the parameters of the proposed water lease, and other options that may be available to obtain replacement water from other sources. Following discussion regarding the Water Lease Agreement Director King moved that the Board table the consideration of the Agreement and directed Mr. Schlegel to return the agreement to the PPW&SD to correct several typographical errors in the document. Upon a second by Director Schwam a vote was taken, and the motion carried unanimously.

Greater Larkspur Forest Health and Fuel Reduction Project Update: Director Johnson stated that all Phase I work has been completed and Phase II work will commence when the weather improves and the snow pack in the area diminishes.

Spring Canyon Gravel Pit Lease Agreement: Mr. Schlegel presented a copy of a proposed Lease agreement that if approved would renew a prior lease for the area through December 31, 2022. The former gravel pit area is being used by the PPMD to store slash collected from the residents of Perry Park. Following discussion Director Schwam moved that the Board approve and execute the Spring Canyon Gravel Pit Lease Agreement between the PPW&SD and the PPMD, as presented. Upon a second by Director King a vote was taken, and the motion carried unanimously.

NEW BUSINESS:

Independence Day 2022 Fireworks Display: Director Brickweg presented an email he received from JR Fireworks regarding the scheduling of the fireworks display in conjunction with the District's Independence Day celebration. Due to supply chain issues, there will be a price increase for 2022. Following discussion Director King moved that the Board appoint Director Brickweg to a Committee of one to negotiate the 2022 fireworks display agreement and bring that proposed agreement back to the Board for their consideration at a later date. Upon a second by Director Schwam a vote was taken, and the motion carried unanimously.

<u>Review of Cash Position and Financial Statements:</u> Mr. Schlegel presented the unaudited Financial Statements dated January 31, 2022 for the Board's review.

Ratification of Claims Paid: Mr. Schlegel presented a list of January 2022 claims for ratification by the Board. After review, Director Schwam moved that the Board ratify the January 2022 claims totaling \$96,989.95 represented by checks #6645 through #6657. Upon a second by Director Brickweg a vote was taken, and the motion carried unanimously.

Approval of Claims: Mr. Schlegel presented a list of claims for consideration and payment. After review, Director Schwam moved that the Board approve the February 2022 claims presented for payment totaling \$4,105.52 represented by checks #6658 through #6670. Upon a second by Director Brickweg a vote was taken, and the motion carried unanimously.
