**PERRY PARK PARADE PARTICIPANT RELEASE AND WAIVER OF LIABILITY
AND INDEMNITY AGREEMENT 2023 FOURTH OF JULY PARADE**

IN CONSIDERATION of permission to participate in the Fourth of July Parade hosted by the Perry Park Metropolitan District ("District"), and having been fully informed of the nature of the parade and the risks inherent in participating, I/we, the "Participants", including his/her their parents or legal guardians, understand that by participating in this activity the Participant runs the risk of physical injury, both internal and external, temporary or permanent, or the risk of death, and may run the risk of developing mental stress.

PARTICIPANT further agrees to the following:

- 1) I/We have independently evaluated and reviewed the risks and determine to engage in the above-listed activity with full knowledge and acceptance of the risk. Fully understanding these risks, I/we, my spouse, legal representatives, heirs, and assigns, hereby agree to assume full responsibility and liability for the risk of bodily injury (including death), or property damage which may result from participation in this activity.
- 2) I/We, for myself/ourselves, my spouse, legal representatives, heirs and assigns, HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE THE PARTICIPANTS, THE DISTRICT, event sponsors and advertisers, and their officials, employees, volunteers, attorneys and agents (hereinafter "Releasees") from all liability to the Participant, his/her/their personal representatives, spouse, assigns, heirs, and next of kin for any and all loss or damage and any claim or demands therefore on account of injury to the person or property, even injury resulting in death,, whether caused by the negligence of the Releasees or otherwise while the undersigned is for any purpose participating in the parade;
- 3) TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them from any loss, liability, damage, or cost they may incur, including reasonable attorney's fees, due to the presence of the undersigned while for any purpose participating in the Parade and whether caused by the negligence of the Releasees or otherwise. I/We further agree to indemnify and hold harmless the Releasees for any acts or conduct on my/our part, of whatever kind or nature whatsoever, while participating in the above-listed activity.

THE UNDERSIGNED expressly agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of Colorado, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. The undersigned has/have carefully read the foregoing assumption of risk, waiver, release, and discharge provisions and know(s) and understand(s) fully the contents of said provisions. No oral representations, statements or inducements, other than the foregoing written agreement have been made.

I have read the foregoing Participation Assumption of Risk, Release, Waiver, and Discharge and understand that by signing it I am agreeing to give up substantial rights and have signed it freely and without any inducement or assurance of any nature.

All participants in the parade must complete and sign a waiver form. One waiver form per person.
